Personal data that we process

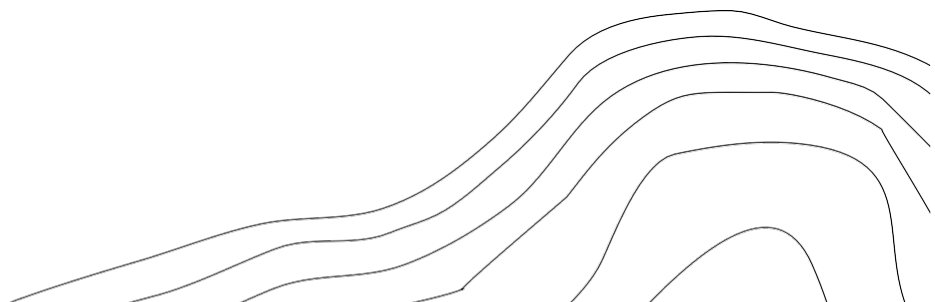
Strandhotel Westduin processes your personal data because you make use of our services and/or because you have supplied the data to us.

Below you will find an overview of the personal data that we process:

- First name and surname
- Date of birth
- Place of birth
- Address
- Telephone number
- Email address
- IP address
- Data relating to your activities on our website
- Data relating to your surfing behaviour on various websites (for example, because this company is part of an advertising network)
- Internet browser and type of device

Special and/or sensitive personal data that we process

Our website and/or service is not intended to collect data about visitors to the website who are below the age of 16, unless they have the permission of parents or guardian. However, we cannot check whether a visitor is above the age of 16. So, we advise parents to take an interest in their children's online activities, to prevent data about children being collected without parental consent. If you are convinced that we have collected personal data relating to a minor without consent, contact us via operations@westduin.nl, and we will delete this information.



For what purpose and on what basis do we process personal data?

Strandhotel Westduin processes your personal data for the following purposes:

- To send our newsletter and/or advertising brochure
- In order to be able to call you or email you, if this is necessary in order to perform the services we provide
- To inform you about changes to our services and products
- To supply goods or services to you
- Strandhotel Westduin analyses your behaviour on the website in order to improve the website and to align the products and services that we offer to your preferences.

How long do we retain your personal data?

Strandhotel Westduin retains your personal data no longer than is strictly necessary in order to achieve the purpose for which your data is collected.

Sharing of personal data with third parties

Strandhotel Westduin does not sell your data to third parties and will only disclose it if this is necessary for the performance of our agreement with you, or to comply with a statutory obligation. We conclude a processing contract with companies that process your data at our behest, in order to ensure that the same level of security and confidentiality of your data is maintained. Strandhotel Westduin remains responsible for this processing.

Cookies, or comparable techniques, that we use

Strandhotel Westduin uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in your browser on your computer, tablet or smartphone when you first visit this website. Strandhotel Westduin uses cookies with a purely technical functionality. These ensure that the website works properly, and that for example your preferred settings are remembered. These cookies are also used to make the website work well and in order to be able to optimise it. Besides this, we place cookies which record your surfing behaviour, so that we can offer you tailored content and advertising.

At the time of your first visit to our website we informed you about these cookies and requested your permission to place them.

You can unsubscribe for cookies by adjusting the settings of your internet browser in such a way that it no longer stores cookies. Besides this, you can also delete all the information that has previously been stored via the settings of your browser.



Viewing, adjusting or removing data

You have a right to view, correct or remove your personal data. Besides this, you are entitled to withdraw your consent for the processing of data or to object to the processing of your personal data by Strandhotel Westduin, and you have a right to data portability. This means that you can submit a request to us to send the personal data that we have about you either to you or to an organisation named by you, in a computer file.

You can send a request to view, correct, remove or transfer your personal data, or you can give notice of the withdrawal of your consent or an objection to the processing of your personal data to: operations@westduin.nl.

In order for us to be sure that the request to view is made by you, we ask you to send a copy of your identity document together with your request. On this copy you should black out your passport photo, MRZ (machine readable zone, the strip with numbers at the foot of the passport, passport number and Citizen Service Number ('BSN')). This is in order to protect your privacy. We will respond to your request as soon as possible, but in any case within four weeks.

How we protect personal data

Strandhotel Westduin takes the protection of your data seriously and takes appropriate measures to prevent abuse, loss, unauthorised access, undesired publication and unauthorised amendment.
